NPETE DOT Training

DOT Haz Mat Regulations Train-the-Trainer and Awareness Courses

National PETE is pleased to announce that we have been awarded a one-year grant from the Department of Transportation to prepare DOT Haz Mat Transportation Regulations trainers. There are several levels of training to be provided:

- 16-hour DOT Haz Mat Regulations course
- 40-hour Regulations and NESHTA Instructional Technology training
- 2-hour Regs Awareness courses to be offered with CCCHST Refreshers *

Those who enroll in the 16- or 40-hour courses must take an online prerequisite.

Nearly all costs, including travel to training, will be covered by the grant. (\$425 towards transportation (air/car), plus overnight accommodations reimbursement at PETE designated hotel and Per Diem for meals.) These expenses will be reimbursed by NPETE. *Attendees expected to bring laptops for use in class.*

January 9-13, 2017: The 40-hour course on HazMat Regulations and Instructional Design for 15 CCCHST and NESHTA instructors. Will be held at Indian River State College, Fort Pierce, FL.

April 24-28, 2017: The 40-hour course on HazMat Regulations and Instructional Design for 15 CCCHST and NESHTA instructors workshop will be held at Cypress Mandala, Inc. Training Center in Oakland, CA.
